HOMEOWNER SESSION

Homeowner from 29212 Tieree St. presented a request to have the 2 black bark Eucalyptus trees that are against his fence on HOA property be trimmed due to overgrowth. This will be added to the Harvest Tree trimming approval.

Homeowner also expressed concerns that his neighbor behind him will not trim his trees. The trees do not encroach over his property but are messy and block the sunlight. Homeowner was informed that this is a neighbor to neighbor issue and that he should write the neighbor and request that he trim the tree. The CC&R's do not allow the Board to intervene in this. If the owner is not successful he can contact Code Enforcement to see if they can assist.

The Board reviewed the current financial statements for the month of October 2020. A motion was made by Director Kirk, 2nd by Director Thompson to approve the financial statements, pending final review by CPA. Current cash balance as of 10/31/20 was \$1,249,028.03 All in favor, motion carried.

Pickleboard/Basketball court bid #12804 \$60,528.80

A motion was made by Director Powell, 2nd by Director Kirk to approve the bid as submitted. Bid does not include the nets for the court. All in favor, Motion carried.

Trail repair and slurry bid##12802 \$3610.20 –need to add additional trail area and send to the Board for approval. Director Powell will meet with El Camino so that the asphalt repairs will be done in January. Liability issue

Clubhouse parking area asphalt/ slurry bid #12747 \$12,462.00

This includes the asphalt repairs, slurry and sandblasting and painting of all curbs.

A motion was made by Director Powell, 2nd by Director Thompson to approve the bid as submitted. Bid does not include the nets for the court. All in favor, Motion carried.

Asphalt Slurry project. In addition to the asphalt and slurry, the curbs will need to be sandblasted and painted.

COMMITTEE REPORTS

Landscape

Coral Tree on the corner of Niguel and Highland is aged and dying and will need to be removed. A 2nd opinion will be gained and bids will be obtained for the November meeting.

Facilities & Clubhouse

Derek stated that the irrigation enclosure at the front of the clubhouse is in poor shape and in need of replacement. The condition creates a liability due to rusting and possible leakage in interior. A bid request has been sent to Soto Landscape and will be forwarded to the board once received for review and approval.

MANAGEMENT REPORT

The Board reviewed the 2020 Calendar for the month.

The Board reviewed the inspection and Workorder logs.

The delinquency report was reviewed by the Board. Six accounts will be pre-liened for balances exceeding 90 days.

BUSINESS

Joseph Silva from El Camino Asphalt was present to discuss the bids presented for the following areas:

Pickleboard/Basketball court bid #12804 \$60,528.80 APPROVED

Note: Pickleboard court bid was \$38,046.00. Bid was changed to include the pickleboard court as well as a half basketball court so that ball would not be played in the parking area which poses a liability. A motion was made by Director Powell, 2nd by Director Kirk to approve the bid as submitted. Bid does not include the nets for the court. All in favor, Motion carried.

Trail repair and slurry bid# #12802 \$3610.20 –need to add additional trail area and send to the Board for approval. Director Powell will meet with El Camino so that the asphalt repairs will be done in January. Liability issue

Clubhouse parking area asphalt/slurry bid #12747 \$12,462.00 APPROVED
This includes the asphalt repairs, slurry and sandblasting and painting of all curbs.
A motion was made by Director Powell, 2nd by Director Thompson to approve the bid as submitted.
Bid does not include the nets for the court. All in favor, Motion carried.

The Board reviewed the bid from Orange County Fence for the enclosure of the grass area. A motion to approve the bid at a cost of \$9,491.00 was made by Director Kirk, 2nd by Director Siembab. All in favor, Motion carried. Director Powell will meet with OC Fence to proceed.

The Board reviewed the bid from Hills Bros Lock and Safe to install a magnetic reader for the gate that will be installed at the fence between the park fence and the pool fence. A motion to approve the bid at a cost of \$5,269.69 was made by Director Kirk, 2nd by Director Siembab. All in favor, Motion carried.

The Board reviewed the bids to remove the Coral Tree at the Highland/Niguel park area that is failing due to limb hollowness. The tree, which has been there for over 25 years, has a history of major branch failures and is a liability. Harvest Landscape informed the landscape committee that the tree should be removed as it is a liability issue.

Bids for removal and stump grinding:

- Soto Landscape: \$3,958.00
- Harvest Tree Service \$5.000.00

A motion to approve the bid from Soto Landscape at a cost of \$3958.000 was made by Director Kirk, 2nd by Director Thompson. All in favor, Motion carried.

The Board reviewed the bid for the painting of the clubhouse, bathroom and exterior BBQ patio area: Advanced Painting \$4,840.00

Premier Painting \$3,750.00

A motion to approve the bid from Premier Painting at a cost of \$3,750.00 was made by Director Kirk, 2nd by Director Siembab. All in favor, Motion carried.

The Board reviewed the pictures presented for the clubhouse that show the history or areas of CVCA. A number of pictures were chosen. Director Winer will oversee the printing of the pictures that will be displayed after the painting of the clubhouse interior.

There being no further business before the Board, the meeting was adjourned at 8:45PM
