### Check Your Water Bill

Due to recent changes in the way the MNWD bills for water, the association experienced a large increase in the water billing. This was due to MNWD having underestimated the actual area that was being watered, causing us to appear to be using water excessively. That problem was corrected and the billing is now inline. We would like to suggest that you also have your water billing checked and make sure they have properly allotted for the size of your lot that is being watered. *This could save you money!* 

## Key Fobs

As part of the new renovations at the clubhouse parking lot, you will be able to access the new gate system by use of your existing pool key fob. In order to accommodate our residents, the Board has approved the issuance of a 2nd key fob to residents. The cost for the 2nd key fob will be \$50.00. Please note that only two fobs will be issued per household. If you would like to purchase a 2nd fob, please call our management and they will assist you.



# Architectural Changes

Please remember that you may not make ANY change to the exterior of your home without first obtaining written authorization from the association. If you want to make a change, you must submit an architectural variance request form to the management office. The request will then be submitted to the Architectural Committee for review. If approved, you may then proceed with your project. Please note that this process can take up to **30 days**. Your cooperation in this matter is greatly appreciated. THE BOARD HAS ADOPTED A NEW RULE THAT WILL MANDATE THE ASSESSMENT OF A FINE IN THE AMOUNT OF \$250.00 TO OWNERS THAT PERFORM UNAU-THORIZED CHANGES TO THEIR HOME. ALSO, A CEASE AND DESIST LETTER WILL BE SENT FOR ALL UNAUTHOIR-ZED CHANGES AND YOU WILL BE ASKED TO APPLY FOR APPROVAL. FAIL-URE TO COMPLY WITH THE CEASE AND DESIST DEMAND AND NOT SUB-MITTING AN APPLICATION WILL RE-SULT IN THE FINE ASSESSMENT OF \$100.00 PER DAY UNTIL THE MATTER IS PROPERLY APPROVED.
