## New Association Bank effective July 1, 2016

If you are paying online through our website or your bank's bill pay service; you will need to update your payee information to read as follows: Make check payable to your association, P.O. Box 512229, Los Angeles, CA. 90051-0229. Enter your account number. This is an eight digit number which can be found on the top right hand corner of your statement.

If you are writing check, write your account number on your check, include your coupon and mail in the envelope provided.
